### EVENT LAYOUT AND OPERATIONS:

Licensee shall provide Director with a detailed preliminary site plan identifying proposed booth layout (including vendor, vehicle and operational locations), special sponsorship exhibits, beer gardens, required Seattle Center buildings or service facilities (including Harrison Street and Covered Walkway), special venues and stages no later than three weeks prior to first Event date. The Director shall review such site plan and provide comments, if any, within twenty (20) days after receipt. Licensee shall submit for Approval a further revised site plan incorporating the Director's comments and revisions within (10) days from the date of the Director's notice. Licensee shall make no changes to the final Approved site plan unless approved by the Director.
